## SIERRA ROADWORK SCHEDULE Sunday through Saturday December 11 – December 17, 2011

### LONG-TERM PROJECTS

**Interstate 80 Donner Safety Roadside Rest Areas** (Nevada County) Work continues to replace rest area. When this \$12.5 million project is complete, the facilities and parking will be upgraded to meet the demands of the more than three million annual visitors and will be compliant with the Americans with Disabilities Act standards. The westbound facility reopened on November 22. The eastbound facility is scheduled to reopen **December 20**.

**State Highway 49** (Nevada County) Work has begun on the \$29 million Highway 49/La Barr Meadows Project that will widen State Route 49 to four lanes between Little Valley Road and Norambagua Way, just south of Grass Valley. The project includes a signalized intersection at La Barr Meadows Road, widening of shoulders, right-turn pockets and new sound walls. Completion is expected by fall 2012. **Project is in winter suspension.**

**Interstate 80** (Placer and Nevada Counties) from Carpenter Flat to Hampshire Rock: Work continues on the \$167 million Emigrant Gap project on Interstate 80. Work includes total roadway replacement with Portland Cement Concrete, improving the drainage systems and installing new sediment/debris collection systems. Completion is expected in the fall of 2013. **Project is in winter suspension.**

**Interstate 80** (Nevada County) from Donner Summit to Donner Lake: Work continues on the \$71 million Donner III Project to improve Interstate 80. Work includes repaving the existing roadway with Portland Cement Concrete, reconstructing failed sections of roadway, adding new drainage systems, upgrading existing drainage systems and construction of a new sediment/debris collection system. Completion is expected in early winter 2011. **THIS PROJECT IS NOW COMPLETE!**





### SHORT-TERM PROJECTS

**State Route 20** (Nevada County) from the Yuba County line to Interstate 80: Motorists can expect one-way traffic controls from **8 a.m. to 5 p.m. Monday through Friday**. A Caltrans crew is scheduled to do miscellaneous maintenance work.

**State Route 20** (Nevada County) from Bennett Street to Bank Street: Motorists can expect westbound #2 lane and shoulder closures from **7 a.m. to 5 p.m. Monday through Friday**. A contractor is scheduled to construct sidewalks.

**State Route 49** (Nevada County) from the Placer County line to the Yuba County line: Motorists can expect one-way traffic controls in various locations from **8 a.m. to 5 p.m. Monday through Friday**. A Caltrans crew is scheduled to do miscellaneous maintenance work.

**State Route 49** (Yuba and Sierra Counties) from Marysville Road to the Yuba Pass Summit: Motorists can expect one-way traffic controls in various locations from **7:30 a.m. to 4 p.m. Monday through Friday**. A Caltrans crew is scheduled to do miscellaneous maintenance work.

**Interstate 80** (Placer County) from Ophir Road to Lincoln Way: Motorists can expect intermittent lane and ramp closures from **8 p.m. to 7 a.m. Monday through Friday**. A contractor is scheduled to do striping work.

**Interstate 80** (Nevada County) from Donner Park to the Sierra County line: Motorists can expect various east and westbound lane closures from **8:15 a.m. to 3:45 p.m. Monday through Friday**. A Caltrans crew is scheduled to do miscellaneous maintenance work.

**State Route 89** (Nevada and Sierra Counties) from Rainbow Drive to the Sierra County line: Motorists can expect one-way traffic controls at various locations from **8 a.m. to 3:30 p.m. Tuesday through Thursday**. A Caltrans crew is scheduled to do miscellaneous maintenance work.

**State Route 174** (Nevada County) from Bear River Bridge to Auburn Street: Motorists can expect various east and westbound lane closures from **8 a.m. to 5 p.m. Monday through Friday**. A Caltrans crew is scheduled for miscellaneous maintenance work.

**State Route 174** (Placer and Nevada Counties) from Interstate 80 to the Bear River Bridge: Motorists can expect one-way traffic controls from **7:30 a.m. to 3:30 Monday through Friday**. A Caltrans crew is scheduled for miscellaneous maintenance work.





**State Route 174** (Placer County) from Main Street to Rollins Lake Road: Motorists can expect one-way traffic controls from **9 a.m. to 2 p.m. Monday through Friday**. A contractor is scheduled to do underground utility work.
