Citizens' Bond Oversight Committee

On December 9, 2008, the Board of Education approved the establishment of an independent Citizens' Bond Oversight Committee for the successful 2008 bond election. Proposition 39 requires that such a committee be established if a school bond is passed that is subject to the Proposition 39 provisions.

Per State law, seven groups are represented on the Citizens' Bond Oversight Committee and the Board of Education added two at-large designations, for a total of nine members. Each member shall serve a term of two years. No member may serve more than two consecutive terms. The groups are as follows: Business Representative, Senior Citizen, Member of a Taxpayer Organization, Parent of a Lake Tahoe Unified School District student, Parent active in the Lake Tahoe Unified School District PTA or SSC, Member of the South Tahoe Association of Realtors, and a Member Active in the Construction Industry in South Lake Tahoe.

Interested candidates are invited to apply to serve on the committee. Candidates must be at least 18 and reside within the District's boundaries. Employees, officials, vendors, contractors, or consultants of the District are ineligible.

DUTIES OF THE COMMITTEE

The Citizens' Bond Oversight Committee is responsible for the following:

- Reporting to the community whether Measure G funds are spent on projects listed in the Measure G Project List and that no funds are used for salaries or general school operating expenses.
- Following and monitor Measure G projects.
- Receiving and reviewing copies of the annual performance and financial audits of Measure G projects as required by Proposition 39.
- Inspecting school facilities and grounds for compliance with Proposition 39.
- Reviewing deferred maintenance plans.
- Providing information to the public on the progress of Measure G projects.
