RE: Champions Plaza Recognition Policy

### **RECOMMENDATION:**

Hear Staff Report; Receive Public Comment; Receive Council Comments, Provide Direction or Amendments to Proposed Policy; Adopt Champion's Plaza Recognition Policy

### BACKGROUND:

As part of the 2014/2015 Harrison Avenue Project, the City constructed the Champion's Plaza to provide a prominent location to recognize local athletes who reach statewide, national or international recognition in their sport. Champion's Plaza was completed in 2015. In 2015, the City issued a Request for Proposals for Public Art to be displayed in the Plaza bringing further prominence to the recognition of local champions. On July 7, 2015, the City Council awarded a contract to artist David Foster to sculpt a bronze "Champion's Flame" to be installed in the plaza.

#### ISSUE AND DISCUSSION:

This item is before the City Council to consider adopting the proposed Champion's Plaza Recognition Policy. The policy defines the criteria applicants will be required to meet in submitting a request to be inducted and honored in the Champion's Plaza area. Adoption of this policy will allow the City to begin receiving applications for potential champion honorees.

#### FINANCIAL IMPLICATIONS:

Cost of the plaques is proposed to be borne by the champions recognized. The City or the recognized Champion could hold fundraising events for the cost of the plaque(s).

# CHAMPIONS' PLAZA RECOGNITION POLICY

# POLICY PURPOSE

The Champion's Plaza was constructed to recognize outstanding achievement by local athletes who achieve distinction in their sport at the state, national or international level. The City of South Lake Tahoe is proud of its local athletes, many of whom have competed in the Olympics and brought recognition and attention to the Lake Tahoe region. Champion's Plaza will be a place to publicly acknowledge the outstanding achievement of our community members. The Champion's Plaza is not intended to recognize lifelong or enduring achievement in a particular field unless the applicant is recognized at the state, national, or international level for such lifelong achievement.

# CRITERIA AND ELEMENTS

An applicant for recognition in the City of South Lake Tahoe Champion's Plaza will be required to satisfy the minimum number of elements from each of the four (4) criteria described within this policy. Applicants must meet the requirement listed in Criterion I (Eligibility: Level of Achievement), must meet at least two (2) of the elements from Criterion II (Identity with the Lake Tahoe Region), must meet at least two (2) of the elements from Criterion III (Significance of Achievement), and must complete Criterion IV (Achievement History).

# **CRITRION I - ELIGIBILITY**

# STATEWIDE, NATIONAL, OR INTERNATIONAL LEVEL OF ACHIEVEMENT

The following eligibility requirement must be met before a nominee can be considered for possible induction into the Champion's Plaza.

#### **Eligibility Level of Achievement**

The level of achievement by the individual or team must be achieved at the statewide, national or international level and must recognized and understood as a standard in the sport as achievement at that level. The achievement must be explicitly described. For example, "national figure skating" achievement *would not be acceptable* explanation. However, "2015 U.S. Figure Skating Bronze Medal Champion" would be acceptable.

#### Exceptional Individual Achievement:

An exception to the eligibility requirement would be the opportunity for nomination of first-time achievements (examples: first South Lake Tahoe resident to swim the English Channel, first South Lake Tahoe individual or group to climb

## **CRITERION II – IDENTITY WITH LAKE TAHOE REGION**

Applicant must meet at least two (2) of the following elements before s/he can be considered for possible induction into the Champions' Plaza. The applicant must consider South Lake Tahoe to be his or her home or identify with South Lake Tahoe and/or the Lake Tahoe Region in such a way they represent the Lake Tahoe or South Lake Tahoe in their sport.

#### ELEMENTS:

#### 2.1 Born in the South Lake Tahoe area.

Applicant's parent or parents resided in the South Lake Tahoe area at the time of his/her birth.

#### 2.2 Resident of South Lake Tahoe.

Applicant currently resides in the South Lake Tahoe <u>or</u> resided in the South Lake Tahoe community during the time in which s/he competed to achieve the recognition for which they are applying to be honored.

#### 2.3 Resident of South Lake Tahoe area for at least ten years before or after achievement.

Applicant lived in the South Lake Tahoe area for at least ten years prior to or after the time in which they competed to achieve the recognition for which they are applying to be honored.

#### 2.4 Brought State, National or International Recognition to Lake Tahoe.

Applicant may have trained in South Lake Tahoe or the Lake Tahoe region, which subsequently brought state, national or international recognition to the greater Lake Tahoe area during the time in which they competed for the achievement for which they are applying to be honored. Applicant should provide evidence of state, national, or international recognition including press coverage indicating applicant is from "Lake Tahoe," or "South Lake Tahoe." Submission of press clippings and other examples of media coverage are required.

#### 2.5 Worked (or has worked) within the community or owns a business in South Lake Tahoe.

The applicant is a past or present South Lake Tahoe area business owner or worker who has contributed in a special way to the community.

#### 2.6 None of the above.

An applicant may still be considered if unable to meet the preceding elements by providing sufficient documentation to demonstrate the applicant's identity with South Lake Tahoe or Lake Tahoe. The significance of the applicant's association and identity with Lake Tahoe will be evaluated by the review committee.

## **CRITERION III – SIGNIFICANCE OF ACHIEVEMENT**

Applicant must meet at least two (2) of the following elements before s/he can be considered for possible induction into the Champions' Plaza. The applicant must fully explain the significance of the achievement. It must be further specified if the achievement is the result of an individual or team effort. If application is for team recognition, team will be recognized as a whole.

#### ELEMENTS:

#### 3.1 Recognition of the achievement by the South Lake Tahoe community.

Applicant must describe how the community has been affected by the achievement as well as the manner in which the community has responded (e.g. local press (print and web) coverage received subsequent to achievement, submission of press clippings and other examples of media coverage).

#### 3.2 Peers recognize this achievement as outstanding.

Persons in the same field must recognize the achievement as outstanding and worthy of recognition. A statement of endorsement for the applicant from leaders in the applicant's field is required, which may include coaches, field professions, current and former athletes, etc.

### 3.3 The achievement has improved the quality of life for South Lake Tahoe area residents.

For example, the achievement may have resulted in increased educational or recreational opportunities for area residents, brought state, national or international recognition and funding to local organizations or community groups.

#### 3.4 The achievement has improved the sport for which the athlete is being recognized.

Applicant may submit documentation, endorsements and media coverage to demonstrate applicant's achievements have improved the sport for which the athlete is requesting to be honored. For example, the applicant may have worked with youth to encourage interest in the sport; taught, mentored or inspired others to enter the sport and compete on the state, national or international stage.

# CRITRION IV - HISTORY REQUIREMENT

Applicant must provide a statement of the history of their achievements in the sport. The statement must be in narrative form and in sufficient detail to completely support the conferring of the honor of being inducted into the City's Champion's Plaza. The history must provide sufficient information to enable future readers to completely appreciate the significance of the applicant's contribution. Include, if possible, documents, press clippings, photos, or other examples of media coverage related to the achievement. If the history is written by anyone other than the applicant, (for example, a parent, a coach, trainer or another) it must be read and signed by the applicant (when possible) and thus documented as a true and accurate account. If the award is conferred, the history will be placed in the South Lake Tahoe City's archives (held in the City Clerk's records) to serve as a reference and permanent record of the achievement.
